**TOPIC:** 2025-2026 Capital Budget Planning

**POLICY** 1.3.1 Budgeting – may not cause or allow budgeting which contains too little information, as determined by the Board to enable *credible projection* of revenues and expenses, separation of capital and operational items, cash flow, and disclosure of *planning assumptions*.

**1.6.5 Asset Protection -** may not make any purchases or commit the organization to any *expenditure of greater than \$50,000.* 

**INTERPRETATION:** *Credible projections* are based on multiyear plans supporting community benefits statements and executive limitations. *Planning assumptions* are based on multi-year capital expenditure plans and funding sources. *Expenditures greater than* \$50,000 must have board approval.

DATA/RESULTS: Attached are three planning documents.

- 1. 2025-2026 Capital Expenditure Funding Sources shows the funding plan for the next year's capital budget.
- 2. 2025-2026 Capital Expenditure Summary shows categories of capital expenditures for next year's capital budget.
- 3. 2025-2026 Capital Equipment Budget Requests provides additional information and identifies *expenditures greater than \$50,000* requiring board approval.

At this meeting today, NTC is presenting the Board with a resolution to approve capital expenditures of \$13,864,807 which includes a May 2025 borrowing of \$13,000,000, anticipated grant funding of \$196,000 and projected fund balance usage of \$668,807.

MEETING DATE: March 4, 2025

#### TOPIC: Remodeling: Wausau – Accommodations, Testing, & Security Renovation

**POLICY: Wisconsin Statute 38 – Technical College System, 38.14 District Board Powers –** (2) Buildings and Equipment. (a) For the use of the district schools the district board may: (3) Construct, enlarge, or improve buildings.

**TCS 5.04 (4) (a)** A resolution of the district board approving the remodeling of existing facilities, (b) A resolution of the district board requesting board (WTCS) approval of the remodeling.

**INTERPRETATION:** Remodeling of existing facilities requires Board approval.

**DATA/RESULTS:** This project focuses on renovating 3,200 square feet of space in the C Building for the Accommodations and Testing Center, as well as the Security office suite. The renovation will feature enhancements to the security suite that includes private security offices designed for increased visibility to the Information desk and common corridors. The suite will provide ample office space for three full-time security staff and will incorporate a new exterior entrance for quick access to the security vehicle. Additionally, the suite design will include open office areas for greeting visitors.

The Accommodations and Testing Center will be significantly upgraded to enlarge staff offices, ensuring full wheelchair accessibility. The plan includes three single-use quiet testing rooms and two larger group testing rooms, all designed to maximize natural light and visibility for staff overseeing assessments. A waiting area, complete with lockers and staff cubicles, will be integrated within the suite, enhancing the overall functionality of the space.

All renovations will be executed with a strong emphasis on meeting and exceeding ADA compliance standards. The estimated budget for the project is not to exceed \$700,000. In order to begin construction this spring, the College will be requesting WTCS State Board approval at its May Board Meeting. The NTC Board is asked to approve the proposed renovation and request the WTCS State Board to do the same. A packet evidencing compliance with the statutes will be submitted to the State Board with the application.

The renovation will create two new classrooms, staff office space, and restrooms, while also insulating the entire building and adding heating to the truck storage bays. This redesign will position the classrooms adjacent to the outdoor utilities field and practice areas, eliminating the need for students to drive trucks back and forth between learning spaces, which currently disrupts their training with time-consuming bathroom and warming breaks.

By consolidating classroom and practice areas, the project aims to facilitate a more fluid learning environment, minimizing disruptions to training sessions. Additionally, the renovation will include the installation of a new well to supply water to the building, along with a septic system to service the new restrooms.

The total cost of the project is estimated not to exceed \$800,000. In order to begin construction early summer, the College will be requesting WTCS State Board approval at its May Board Meeting. The NTC Board is asked to approve the proposed renovation and request the WTCS State Board to do the same. A packet evidencing compliance with the statutes will be submitted to the State Board with the application.

By providing a dedicated space for dry cows, the project will also enhance their quality of life by allowing them access to pasture.

The new stall, along with two existing stalls, will be equipped with automated gates and a cow lane, enabling the cows to pasture themselves. This innovation eliminates the need for manual handling, significantly improving operational efficiency by removing the labor-intensive process of moving cows to pasture twice a day.

Overall, this project is designed to enhance animal welfare, boost milk production, and improve farm staff efficiencies. The total cost of the project is estimated not to exceed \$225,000. In order to begin construction this summer and have the dollars expended by June 2025, the College will be asking the WTCS State Board for approval of this project at its May Board meeting. The Board is asked to approve the proposed addition and request the WTCS State Board to do the same. A packet evidencing compliance with statutes will be submitted to the State Board with the application.

# Tiny Artists: AVA looks to expand its youth programs

ANTIGO — Antigo Visual Arts, a nonprofit group devoted to encouraging the arts community in the Antigo area, is looking to expand its youth programming, after seeing success with its first weekly youth art class.

The arts advocacy group launched a Tiny Artists class in 2024, an hour-long weekly art class for children ages 0-5, meant to encourage creativity and expression in Antigo's youngest artists.

Tiny Artists was launched in 2024, after the opening of the AVA Art Center, and activities are geared toward kids that haven't gone to school yet, or are homeschooled. In addition to a creative outlet, it also offers community through art.

"Little ones can explore their creativity through story time, fun paper crafts, tastesafe homemade paints and hands-on projects that ignite their creativity," the AVA website said.

The classes are called a "delightful art playtime," and offers a "safe, friendly environment perfect for curious minds and tiny hands." The Tiny Artists art class is held every Tuesday morning at 10 a.m. at the AVA Art Center, the nonprofit's art space which opened in summer 2024 which has significantly expanded AVA programming and offerings. The art center is located at 1350 N. Hogan Road, next to the Aspen Village office.

Madison Taylor is the public art chair on the AVA board of directors. She also owns her own art studio on Clermont Street, called Creative Phoenix, which offers art classes at a cost for area teens and adults, along with her own art for sale.

Taylor is the instructor of Tiny Artists, and took over the program in October 2024. She said that the program has a handful of regular participants, and while the class is still getting off the ground, AVA has seen the positive effects of the classes, but those often class.

"My favorite part is seeing how everybody does their (projects," Taylor said at a Tiny Artist she taught in January. "It's so different."

Kids can all be handed the same instructions on a project, and each approach it differently, she continued. They'll each start at the same place, and approach it differently.

Activities at the Tiny Artists class can range everything from edible projects and painting to sensory projects and building 3D items to take home.

The AVA board of directors in 2025 is looking to expand its classes for youth in the community to all ages, hoping to add two additional art class sessions.

Taylor said AVA would like to see one session open to ages 6-12, and one session for teenagers ages 12-18.

Right now, AVA is in the process of seeking funding to expand its

youth classes, applying for grants and funding from local groups. AVA would like to add a second instructor, and open class times up to more ages, Taylor and Gabriel said.

Taylor said that she's had teenagers participate in and express interest in her Creative Phoenix cost students money in order to cover costs. AVA would like to partner with Taylor to offer a low cost or free option for students.

"We want to reach kids that can't always afford it," AVA President Danna Gabriel said.

Taylor envisions reaching at least 30 kids a week, between the months of October and April, but details of what the classes would look like, the timeline of their launch and the schedule are still being worked out.

In addition to the Tiny Artists classes, AVA also works with local youth through a regional art exhibit. The Wisconsin Regional Art Program is a statewide art exhibit program where communities hold juried shows for nonprofessional artists across the state.

AVA helps coordinate both the adult program and the teen program. Through the WRAP-Teen exhibit, teens ages 13-19 can exhibit their

work in local and state exhibits, get recognized for their work and receive feedback and cash prizes. This year's show dates are April 7 through April 17 at Northcentral Technical College, and the entry deadline is March 28.

The program is meant to connect to Antigo students, help encourage their art pursuits and give them an opportunity to show their work. Antigo Visual Arts offers a wide variety of artistic opportunities for artists of all ages. From gallery shows to help artists sell their work, to public art projects like

### Loyal board approves new high school courses

#### By Valorie Brecht

At its last meeting held Jan. 29, the Loyal School Board approved several new courses for the 2025-26 school year, those being: sports entertainment and management (0.5 credit, one trimester); environmental science (0.5 credit, one trimester); astronomy (0.5 credit, one trimester); advanced welding (0.5 credit, one trimester); multi-tiered system of supports (MTSS) math intervention (0.25 credit per trimester); MTSS English and language arts intervention (0.25 credit per semester); parents and children (0.5 credit, 3 credits through Chippewa Valley Technical College (CVTC)); and foundations of early childhood education (0.5 credit, 3 credits through CVTC).

Teachers had the opportunity to submit course proposals, which were then reviewed by administration and submitted to the board for final approval.

The sports entertainment and management class is an elective through the business education department. The two science classes will provide additional opportunities for students who are not planning on pursuing university after high school but still need to fulfill their science credit requirement. These classes are less rigorous than chemistry or physics, for example.

Advanced welding will provide a bridge between the intro to welding course and the college-credit welding course, as the teacher felt students needed more practice before jumping into the college-level course.

The intervention courses are for students who are identified in the FastBridge assessment as needing extra help. They will receive small group instruction and will earn credit for the course as an elective. These remedial courses will not take the place of the math and English classes they will still be required to pass to graduate. The two family and consumer education classes will be offered at Greenwood with Kristin Jaenke. They will allow students to work in a daycare setting and earn college credit, whether it is a private daycare facility in Loyal or Greenwood, or the Lil' Dawgs afterschool program in Loyal.

While the board was discussing courses, board president Dennis Roehl asked if there were opportunities for students to earn their commercial driver's license (CDL) through CVTC or Northcentral Technical College. District Administrator Chris Lindner said the district had had conversations about it, but hadn't tried it yet. Students in Neillsville have taken CDL training through the CVTC satellite campus there, so that program is set up. Lindner said if there was interest, the school district would have to work with the individual student to see if the course could fit in their schedule.

Board member Kirk Haslow also had a comment. He said he was all for additional curriculum, but wanted to know if the district would have to hire more teachers to offer additional courses.

"No, so I guess going back to that strategic plan, the concern was that we do not have enough courses for kids that are not necessarily going to that higher level four-year college, that we need some more trade courses. So this (environmental science or astronomy) would be taught within our science teachers right now," said Principal Angie Kollmansberger. "So it's just an additional offering. It doesn't mean it's taking the place of another course."

Board member Derek Weyer also mentioned that the curriculum committee recently had a good discussion on weighted grades and planned to bring it before the full board at some point.

## **Residents get look at plans** to revamp Rib Mountain

Residents on Thursday got a look at a concept plan for revamping Rib Mountain - but DNR leaders say any action on the plans is probably a ways off.

The Department of Natural Resources held the meeting Thursday at Northcentral Technical College. DNR and IMBA officials presented the plan, which was developed by the Greater Wausau Prosperity Partnership through a memorandum of understanding with the DNR.

The plan so far is just a concept, explained DNR Recreations Partnerships Section Chief Missy VanLanduyt. The DNR has no funding for any of the plans and development of anything outlined would need to be funded by user groups proposing the changes, VanLanduyt told City Pages.

The concept plan is the latest in a process that went back to 2014 when Granite Peak owner Charles Skinner announced he would be petitioning the DNR to expand his ski trails. After numerous public meetings, public pushback and revised plans, the Natural Resources Board ultimately decided to relook at the entire park's master plan, which could allow for more uses at the park.

The Natural Resources Board at the end of 2022 approved the new master plan. Then things went quiet and DNR officials struggled to answer what the next steps would be in questions from City Pages.

The plans included a path circumnavigating Rib Mountain State Park, a shareduse community trail, improved trailheads for the hiking trails, several mountain biking trails ranging from beginner to advanced and lift-assisted trails, Granite Peak expanded ski operations and the realignment of some snowmobile trails.

Attendees were given a survey to fill out. No public comment was taken at the meeting.

That refuse includes grease, rags, wipes and toothpaste tubes, according to a post on social media by the village.

# New forensic science center in Wausau to transform death investigations

A long-awaited <u>regional forensic science center</u> set to open later this year is expected to revolutionize death investigations in central and northern Wisconsin, eliminating the need for police and medical examiners to travel hundreds of miles for autopsies.

Currently, law enforcement and medical examiners must travel to facilities in southeastern Wisconsin, losing valuable time and resources in the process. The <u>new forensic science center</u> will change that by providing a state-of-the-art local facility, reducing delays and offering critical support for grieving families.

Marathon County Administrator Lance Leonhard spoke with WPR's Shereen Siewert about the new center. He said the facility will improve efficiency in death investigations and serve as a training hub for forensic professionals.

Beyond its role in forensic investigations, the center will also facilitate tissue donation services, filling a critical gap in northern Wisconsin.

<u>The project</u>, in development since 2017, is a partnership with North Central Technical College and the Medical College of Wisconsin and will offer hands-on educational opportunities for nursing students, surgical technicians, prosecutors and law enforcement.

"We are striving to make this facility more than a morgue, to really offer those opportunities whether you're just starting your education or you're in the career field right now and looking for that continuing

education," Leonhard told Siewert, on "<u>Morning Edition</u>." "There are all sorts of educational opportunities that this facility will permit."

With the region's first forensic pathologist set to begin work in August, Marathon County is preparing for the center's rollout. Initially, it will focus on handling local cases while refining operational procedures, with the goal of accepting cases from surrounding counties soon after.

If things are good and we're able to get into the closest facility that we have to procure a forensic autopsy, we're traveling all the way to Fond du Lac. We sometimes need to travel to Dane County to the University of Wisconsin system to have those autopsies performed.

What that means is not only that our medical examiner staff or death investigators are traveling out of the county and essentially spending an entire day outside of our service area, but also local law enforcement. Listen

LL: First and foremost, I think one of the things we always need to remember is that the families that we deal with are going through some of the most traumatic experiences you can imagine, the unexpected loss of a loved one.

This facility is going to bring a more timely resolution to a lot of the questions that they might have to help them understand that situation and allow them to get those answers without having to leave the

community. They won't have to travel to Dane County or to Fond du Lac or to Milwaukee. They're going to get those answers here and get that local support.

They'll have the opportunity to be counseled by our staff and have those timely resolutions.

I also think that we're being very intentional with the design of the center to create spaces where families that come to visit us, whether it's for a body viewing or having a conversation with one of our investigators or pathologists, have a space that is as warm and comforting as it can be.

#### SS: Tissue donation is another component of this center. How will that work?

**LL:** We're very fortunate in Wisconsin because a majority of the individuals in the state are tissue donors. But there are not enough tissue donation spaces that are readily available for that throughout the state.

When we think about the fact that any one individual who is a tissue donor has the opportunity to impact, in a very positive way, more than 50 people, anything we can do to expand that access will pay a lot of dividends for the people and medical providers in our community.

Our facility will provide that space. We're working to partner with tissue procurement entities to make sure that when those opportunities arise, we can maximize them.

# SS: The partnership with North Central Technical College and the Medical College of Wisconsin is a unique aspect of this project. How will this collaboration work in practice?

**LL:** When the task force started back in 2017 and really dove into this issue, we found it involved much more than just delivering core government services like death investigations and autopsies. We're hoping to work with NTC and the UW to allow that hands-on opportunity that doesn't exist right now.

After a distinguished career in law enforcement and education, Brian Fiene retired from Northcentral Technical College (NTC) in December. His journey to law enforcement began when he was still in high school and met a couple of officers. They weren't just figures of authority; they were role models. They treated others with dignity and respect and made a difference in their community.

Brian began his career in law enforcement at a very young age as an officer in Milwaukee. Working in Wisconsin's largest city was a stark contrast to his life growing up in a small town in the northwestern part of the state. He faced some challenges as he adjusted to the culture and learned to connect with people who had more life experiences than he did, but with each shift, each call and each person he helped, he grew into his role.

People rarely think about law enforcement during the good times. They do not call when things are going well; they call when they are in times of crisis, sometimes on the worst day of their life. In those moments is where Brian found his greatest reward. For him, every day was an opportunity to positively change a person's life.

He has responded to too many incidents to count over the years: crimes in progress, medical emergencies, industrial accidents, traffic crashes, Some had good outcomes and some did not. One traffic crash that has always stood out to him was a minor crash on a slippery morning. There were no injuries, and there was no serious damage.

"One of the drivers was so emotionally distraught over the fact she rear-ended a car that she asked me to move her car off the road and have it towed- despite the fact it was drivable," he said. "She later sent a letter of thanks to the chief commending my work. To me it was a 'nothing crash,' but to her it was a significant event in her life. It is nice to have someone thank you for making their circumstances better by what you do."

As the years passed, Brian and his wife, Melinda, decided they were interested in raising their two sons outside of the Milwaukee area. They were familiar with Wausau because they had friends that lived here, and Brian knew he liked teaching after having taught Standard Field Sobriety Testing around the state, so when the instructor position at NTC opened up, it seemed like fate.

Brian brought a lot of knowledge and experience to the criminal justice program at NTC. He held a lot of different positions prior to his first full time job and had a lot of experience: small towns and large cities, municipalities, natural resources, universities, special events, uniform, undercover, jails and communications.

"This allowed me to be able to have an actual example of something I was involved in for most topics in my classes," he said. "I always tried to illustrate a concept or topic with an actual event I was involved in and explain how the classroom material related to the event."

As he settles into retirement, Brian is looking forward to spending more time outdoors on the water and in the woods, as well as traveling with his wife and helping his sons with projects. He also hopes to return to teaching in some capacity in the future.

Over the years, Brian has watched many students graduate and go on to positions of leadership and specialization across the state.

"I have received two contacts from graduates that I will not ever forget," he said. "One was a letter from an officer who had been thrown several feet from an explosion at a car crash scene and was able to continue to function based on his training. The other was a phone call from an officer who had stopped a car and been shot at by the driver. The officer was able to stay safe and respond appropriately based on his training.

"Both contacts ended with the officers telling me, 'Thank you for keeping me alive,'" he added. "I don't know how it can get any more rewarding than that."

Although he is no longer there for the day-to-day training, Brian leaves some advice for future law enforcement professionals.

"Make sure you are doing this for the right reason - to make a difference," he said. "There are a lot of easier ways to make a living. This will get more difficult as you go on. Remembering that you are doing it for the right reason will keep you grounded when everything else is chaos around you."
