A. Approval of Minutes from October 18, 2022 Board of Trustees Regular Meeting

B. Final Modifications to the 2021-2022 Budget – Roxanne Lutgen

E. 2022-2023 Capital Budget Planning – Mid-Year Revision – Roxanne Lutgen

Troy Brown moved and Paul Proulx seconded Northcentral Technical College District Board approval to revise the 2022-2023 capital budget to include grant-funded expenditures and reallocate certain capital expenditures, with no modification to funding approved in March 2022, including identified items exceeding \$50,000. Motion carried unanimously.

F. CNA Mobile Trailer – Capital Purchases > \$50,000 – Roxanne Lutgen

Sherry Bunten moved and Keith Langenhahn seconded Northcentral Technical College District Board approval to utilize \$190,000 of HEERF grant funds to purchase a CNA Mobile Trailer costing approximately \$190,000 for use in our nursing program. Motion carried unanimously.

G. Insulated Modular Grow Pod – Capital Purchases > \$50,000 – Roxanne Lutgen

Paul Proulx moved and Troy Brown seconded Northcentral Technical College District Board approval to utilize \$53,750 of WTCS grant funds to purchase an Insulated Modular Grow Pod costing approximately \$53,000 plus facility and installation costs for use in our Garden to Market Specialist program. Motion carried unanimously.
