

# DISTRICT BOARD OF TRUSTEES ORGANIZATIONAL/REGULAR MEETING

### **CALL TO ORDER**

The Northcentral Technical College District Board of Trustees met on July 10, 2023 at the Wausau Campus as well as via Zoom. Chairperson Tom Felch called the meeting to order at 1:00 p.m.
