The Northcentral Technical College District Board of Trustees met on March 7, 2023 at the Wausau Campus as well as via Zoom. Chairperson Tom Felch called the meeting to order at 1:00 p.m.

B. Approval of 2023-2024 Final Capital Budget – Roxanne Lutgen

Paul Proulx moved and Troy Brown seconded Northcentral Technical College District Board approval of the 2023-2024 Capital Budget not to exceed the \$13,301,003 capital expenditures budget, funded through capital borrowings of \$12,000,000, anticipated donations of \$150,000 and anticipated fund balance usage of \$1,151,003, including identified items exceeding \$50,000.
