Students must maintain a cumulative 2.0 GPA to be eligible for VA Benefits at NTC. Failure to meet this guideline will result in:

- VA Benefit Probation – 1<sup>st</sup> semester (certification for benefits will be processed, as usual)
- VA Benefit Suspension – 2<sup>nd</sup> semester (certification for benefits will not be processed)

Students must attain a 2.0 term GPA during the appeal semester to have benefits continue. Failure to do so will result in an automatic suspension of VA Benefits for one academic semester.

The VA requires students meet minimum academic standards in order to remain eligible for VA Benefits. As a condition of having my VA Benefits reinstated, I agree to the following:

1. I must earn a cumulative grade point average of 2.0 or higher in order to remain VA Benefit eligible.
2. During my appeal semester, I must earn a 2.0 term grade point average to continue using VA Benefits.
3. If I fail to attain a 2.0 term grade point average during my appeal semester, I will be ineligible for VA Benefits for one academic semester. After that time, I will have the opportunity to file another appeal in order to have my VA Benefits reinstated.

  - Signed letter from a third party who is familiar with your situation and can support your appeal.

Only complete appeals will be reviewed.

A determination will be emailed within 14 business days of receiving all required documentation.
